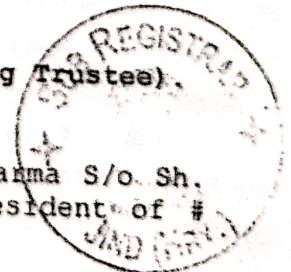

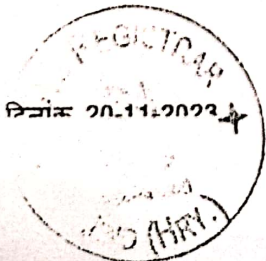

Whereas the continuing trustees & retiring trustees are the trustee of "JAI AMBEY EDUCATIONAL & CHARITABLE TRUST" a trust which is registered by the sub-registrar Jind vide registration no. 5155 dated 23-11-2017 for carrying the charitable activities such as for advancement of education & research, relief to the poor and to do all such other social activities for the welfare of society & general public on such term & conditions as incorporated in the above said trust deed.

And whereas the continuing trustee were in need of some social & energetic hands to smoothly run the said trust and have unanimously resolved that above two incoming trustees i.e. Barjender Chahal & Mukesh Kumar has been induced as trustee of the trust w.e.f. 1st day of May 2023.

And whereas due to death of Sh. Hari Kailash Sharma Trustee of the trust dated on 09-05-2020 deemed as retired trustee. And due to some personal reasons the outgoing trustee Smt. Kavita Sharma W/o Sh. Vikas Sharma had expressed their desire to resign as trustee of the trust & the continuing trustee and incoming trustees had accepted the resignation & accordingly the above outgoing trustee have retired from the trust w.e.f. 1st day of May 2023. The retiring trustees will not be liable for any Government/legal/Personal dues and other payables pending in any manner qua trust and any school run by the trust which may be of past, present and future.

And whereas accordingly there has been some change in constitution owing to simultaneous admission & retirement with effect from 1st day of May 2023.

Sh. Sandeep Kumar shall be Managing trustee of the trust. All the powers of the Managing trustee of the trust now vested in Sh. Sandeep Kumar as new Managing Trustee of the Trust.

That out of the continuing trustee and incoming trustees of the trust Sh. Sandeep Kumar S/o Sh. Ram Kumar trustee shall be entitle to open and operate account(s) of the trust in any Bank(s) in the name of trust.

Principal office of the trust has been shifted at # 108/5, Gandhi Nagar, Jind and the trustees shall be entitled to open or close or shift any branch or office of the trust.
